## **TERMS AND BOOKING CONDITIONS – ROPERS WALK BARN**

We are happy to hold a telephone reservation for 5 working days. If the deposit does not arrive in time this will be seen as a cancellation.

The property will be ready from 3.00 p.m. on the day of arrival and we ask you to please vacate the property by 10.00 a.m. on the morning of departure. The owners reserve a right to enter from 10.30 a.m. to commence cleaning if the property is still occupied.

Bookings will only be accepted on receipt of a non-refundable deposit of 30% of the total holiday cost. For next year's bookings we request a deposit of £75 with the remaining deposit due by the 1st November. The balance is payable in full 8 weeks before the start of the holiday. Bookings made within 8 weeks of the holiday require full payment at the time of booking.

It is a condition of acceptance of your booking that the whole charge is payable, whatever the circumstances of your cancellation. We strongly advise you take holiday cancellation insurance when booking. Guests should notify us, in writing, if they have to cancel their holiday. If your reason for cancellation is not covered by the policy you will be liable for the balance. We will do everything possible to re-let the property in which case we will return the rent paid less £30.00 to cover administration costs.

We request a damage deposit of £100.00 on booking.

The owners reserve the right to refuse any booking or cancel any bookings already made subject to refunding any sums already paid without any further liability on our behalf.

Only persons listed on the booking form are permitted to sleep in the accommodation.

The owners reserve the right to terminate your stay if you or members of your party are believed to be causing a nuisance or not treating the property with due respect.

The owners shall not be liable to you or any member of your party for any loss or damage to you or your property however caused.

Guests are requested to take good care of the property and leave it in a clean and tidy condition at the end of their holiday.

The owners reserve a right to enter the property during your stay if necessary.

We appreciate that accidents do happen but would ask you to please report breakages or damage immediately and you may be liable for replacement or repair.

We do not accept pets, with the exception of guide dogs.
